

Data Protection Statement - IDC Egypt Ltd.

This Data Protection Statement describes how your personal data as a client, supplier or partner of **IDC Egypt Ltd. (ORCA Dive Clubs)** is processed. It explains how **IDC Egypt Ltd.** uses your personal data, which measures are taken in order to protect your data and which rights you have with reference to your personal data.

Introduction

The protection of personal data is an important concern for **IDC Egypt Ltd.** Therefore, **IDC Egypt Ltd.** processes your personal data in accordance with the provisions of the European General Data Protection Regulation and other applicable statutory provisions on the protection of personal data and data security.

1. Purpose of processing, data categories as well as legal basis of processing

IDC Egypt Ltd. processes your personal data exclusively in order to communicate with you, prepare or carry out business transactions or inform you about innovations at your request. In this connection, there are many processing tasks and these have been listed below:

- Support service for clients and interested persons
- Preparation and processing of contracts
- Planning and realising projects
- Informing clients and interested persons about updates and innovations
- Adherence to statutory obligations such as requirements for billing, accounting and auditing

For the above-mentioned purposes, **IDC Egypt Ltd.** processes the personal data which you have provided or which comes up in connection with your business relationship with us. It involves the following data categories:

- Contact information
- Data which is necessary for the development and conclusion of business processes
- Financial data, bank details and information on creditworthiness
- Contract data
- Insurance and loss data
- Data which has to be gathered or processed for purposes of public interest

IDC Egypt Ltd. processes your personal data on the basis of the provisions listed below:

- for the purpose of carrying out business transactions (article 6 (1) (b) of the General Data Protection Regulation,
- for the fulfilment of legal duties (article 6 (1) (c) of the General Data Protection Regulation, or
- for the protection of the interests of **IDC Egypt Ltd.** considering the affected persons' interests which are worth protecting (article 6 (1) (f) of the General Data Protection Regulation
- if in an individual case you issued your consent in the processing of your personal data, this consent is the legal basis of the processing (article 6 (1) (a) of the General Data Protection Regulation

2. Transmission and circulation of personal data

IDC Egypt Ltd. transmits your personal data in the course of processing your transactions pursuant to art. 6 para. 1 lit. a) – c) of the General Data Protection Regulation to third parties and in internal procedures to service providers who can process your data only by our order and our instructions (art. 28 of the General Data Protection Regulation). These partners were vetted by us so as to ensure that they adhere to data protection regulations and they are obliged via contract.

You will find a list of partner companies at the end of the document.

3. Google service reCaptcha

We use the Google service reCaptcha in order to determine whether a person or a computer can make a certain entry in our contact or newsletter form. Google checks on the basis of the following information whether you are a person or a computer: IP address of the terminal device being used, the website which you visit on our page and on which Captcha is integrated, the date and duration of the visit, the identification data of the browser used and the type of operating system, Google account if you are logged on to Google, mouse movements on the reCaptcha surfaces as well as tasks whereby you have to identify pictures. Legal basis for the described data processing is art. 6 para. 1 letter f of the General Data Protection Regulation. There is a legitimate interest in this data processing on our part to guarantee the security of our website and protect ourselves from automated entries (attacks).

4. Storage periods

If no express storage duration is given during the collection, your personal data will be deleted if it is no longer necessary for the fulfilment of the purpose of storage and no statutory retention obligations (e.g. commercial, fiscal or pension-related retention obligations) necessitate longer storage.

5. Revocability of issued consent declarations

In cases whereby you have issued **IDC Egypt Ltd.** consent to process your personal data, you have the right to revoke the issued consent at any time. This means that the processing which was done prior to the revocation on the basis of the consent was legitimate.

6. Your rights

If you get into a business relationship with **IDC Egypt Ltd.** or if you apply for a job or you work there, you have the right to:

- receive information regarding personal data processed by you,
- request for the amendment of incorrect personal data,
- request for the deletion of processed personal data,
- request for the restriction of processing of personal data,
- request for the transmission of data or
- revoke the processing of personal data.
